Paid PCC memberships 2019 \$2109 increase estimated membership income to \$2500 Sue Ellen 1.11.2020: 147 members in 2019 accrued \$2109 in membership dues. Paid about \$68 in PayPal fees.

2019 Balance: Beginning of year: \$7113, End of year: \$4510, Loss: \$2603 over the year.

Reasons: No balanced budget proposed for 2019, still substantially overspent.

PCC dinner \$1000 over budget

Happy Hour appetizers – no money budgeted in 2019, spent \$433.

Lot of other areas where we were over budget marked in red. Sue Ellen increased, decreased or added amounts to 2020 budget (shown in red).

PCC Ride: 2019 Budget \$1000. Over budget actual \$1734. 2018 Actual \$1592.

Lessons learned on purchasing supplies after we completed same day registrations. Sue Ellen "does not have a historical perspective of knowing where we got our funds to begin with." "Presume we used the paying rides to generate income for the club, whereas we now only take a small percentage and pass the rest to a charity. At our current level of losses we shall cease to exist in less than 10 years."

PCC Board to discuss several options to balance the budget:

Current Membership dues: starting budget \$2109.

Current Fixed Costs: Insurance \$900, Web Services \$300, Post Office Box \$120.

Current Other Costs: Remaining \$800 to use.

*Ellen's suggestion:* See additional discussion below (PCC Expenses Discussed)

*Increase membership dues:* PCC Board voted 2.9.2020 to increase dues as of May 1, 2020 to: \$25 member; \$30 family; \$12 student (remains the same).

*Increase what we charge for the PCC banquet to cover the costs:* PCC Board will discuss at a future meeting to increase the General Membership Meeting & Banquet cost per member. Must be a member to attend the banquet.

Eliminate happy hour appetizers paid by the club: Ellen H. suggested PCC purchase and bring appetizers to happy hour locations to reduce the cost of the appetizers. Happy hour during non-cycling months keep members/potential members involved with the club. Ellen H email — reduce the number to once or twice or not at all.

Eliminate the pre-season and end of season parties: PCC Board discussed benefits of pre-season party – brings membership together, brings in new people, sign up new people and returning members and collect fees. Volunteers for PCC Tour – present Tour jobs and sign up

volunteers. Did not discuss benefits of end of season parties. All enjoy the end of season parties. *End sponsorship of LAB, LIB:* PCC Board discussed to keep the \$100 each due to benefit to cyclists from the work of these groups.

End sponsorship of Bike to Work Month: PCC Board discussed CCB is same donation. Agreed to lower the donation from \$430 to \$250.

Smaller donation to charity from annual ride: PCC Board discussed ways to collect donations for KRT at ride and to decrease donation to KRT from \$1200 to \$500 (as shown on the spreadsheet)

Charge more for the ride: PCC Board discussed \$35 per person x 100 people. Key is preregistration to raise this amount. Weather was a major factor for 2019 income from the ride. Rain deterred many show and ride payers. Lower PCC Tour ride expenses through in-kind and cash donations. PCC Tour committee will contact previous sponsors and ask additional sponsors to contribute. Review when and how food is purchased.

Sue Ellen does not propose a balanced budget for 2020. Sue Ellen estimated the costs for 2020 based on previous year's expenses. Red changes on spreadsheet listed below:
